In accordance with HLR Bylaws para 3.2, 3.4, and 4.3 Members of the High Lonesome Ranch Estates Property Owners Association have submitted petitions with sufficient signatures to call for a special member meeting to vote on removing or retaining members currently sitting on the board of directors. The purpose of this ballot is to vote on those member actions.

The ballots will be counted on 5 July 2022, at 6:00pm at the Special Membership Meeting at the Gleeson Jail, 11250 North High Lonesome Road, Elfrida AZ 85610.

You may mail your ballots or bring them to the meeting in person. Mailed ballots must be received at PO Box 215, Elfrida, AZ 85610 no later than 2 July 2022. Do not vote by mail if you intend to vote online.

If we have your email address on file you will receive via email an invitation to vote electronically. The email will come from Election Buddy Elections ([invitations@mail.electionbuddy.com](mailto:invitations@mail.electionbuddy.com)) with a separate email for each lot owned. Check your spam filter if you don't see the emails arrive in your inbox. Do not vote electronically if you have mailed a paper ballot. E-votes must be completed by 4pm on 2 July 2022.

*Note: Pursuant to section 4.3 of the High Lonesome Ranch Bylaws and Arizona Revised Statute (ARS) 33-1813, any director may be removed from the Board, with or without cause, by a majority vote of those voting on the matter at a Special Meeting of Association Members called for this purpose. The number of responses needed to meet quorum requirements: 20% of eligible votes (28 ballots). Percentage of removal/recall votes needed to approve the matter: greater than 50%.*
