- Elfrida Fire Department Update: Chief Zamora, the new Elfrida FC, briefed what services his department could provided to HLR POs even those we are outside of his fire district and stated that his goal with the help from future grants for the property donated by the now disbanded Volunteer Gleeson FD is to construct a heliport and preposition an available water source. He also briefed that he could provide “coverage” to PO on a yearly fee basis based on property values. He can be reached at 520-642-3749 to discuss coverage. **
 - Water Wise (WW) Presentation: Carmen Miller, the U of A Cooperative Extension Representative for the Sulpher Springs Valley area, briefed about the services in water conservation and horticultural assistance that she and her office could provide to HLR POs. - Reviewed the 2009 Annual Meeting Minutes: Key points were read by Eileen.
 - Results of Board vacancy balloting: Fifty nine (59) eligible lots/votes were received and counted by the Nominations Committee. Eileen A won the majority of votes for the vacancy and will now serve a three year term. - Status of CCR vote: Seventy five (75) eligible lots voted (63 for/12 against) and 50 eligible lots/POs failed to return their ballots. The proposed amendments to the CCR did not receive the minimum of 67% of eligible PO/lot's ballots required to gain approval so there will be NO change to our current CCR.
- HLR Budget update: Bob G briefed that for 2010: our biggest expense continues to be road maintenance with \$9200 allocated in 2010 (covers one major and three minor road gradings); -that there was NO dues increase; and - that the amount of dollars owed by delinquent POs was increasing. He reminded us all to pay our dues and pay on time.
- Next Annual Meeting: Tentatively projected for Saturday, 19 February 2011 at the Elfrida Community Center.
- Next Board meeting: A board meeting occurred immediately following the annual meeting.
- Call to the Membership*: No comments/questions.
- Adjournment: The meeting adjourned at 2:50PM .
